**BID INVITATION FOR COMMERCIAL OPERATION OF THE WEIGH BRIDGE
ESTABLISHED AT THE SPICES PARK, SIVAGANGA, TAMIL NADU**

Spices Board has established a Spices Park at Kottagudi Village in Sivaganga District of Tamil Nadu with all basic infrastructure and high-end facilities for processing and value addition of Chillies and Turmeric and warehouses for storage of raw materials and finished products.

The Board now invites bid from the interested parties for leasing the 80 MT pitless type weigh bridge system with accessories at the Spices Park under "As is where is condition" for commercial operation.

Terms and conditions for leasing out the Weigh bridge:

1. The facility will be leased out in "As is where is" Condition.
2. The facility will be leased out for a period of 5 years from the date of signing of the agreement.
3. The rent will be increased @ 5% per annum.
4. Spices Board will provide electricity to the unit on payment on prorata basis.
5. The bidding firm shall have valid GST registration and PAN card.
6. The facility will be rented out to the eligible bidder who has quoted highest rent per month as well as meeting other terms and conditions of the Board.
7. The highest bidder shall execute an Agreement with the Board within 15 days of the receipt of the offer letter from the Board.
8. The highest bidder shall pay an interest free Security Deposit equivalent to three months' rent through online bank transfer to Board's Receipt Account. The security deposit without interest would be returned at the time of handing over the unit to the Board. The security deposit will have to be remitted along with the agreement.

9. The highest bidder will undertake repair works, if any required, at their own cost.
10. Annual Maintenance Contract (AMC) of the weigh bridge has to be taken by the highest bidder from the authorised vendor / service provider.
11. The operator of the weigh bridge should obtain a certificate issued by the Chief Inspector of Weights and Measures.
12. The highest bidder shall take all required statutory approvals / license for operation of the weigh bridge and renew the same periodically.
13. The highest bidder shall take possession of the weigh bridge within 15 days from the date of signing agreement and after the receipt of the security deposit. If the possession is not taken within 15 days from the date of agreement, it will be treated as a breach of the tender conditions, and the Board has the right to cancel/terminate the lease agreement and exercise the right to lease the unit to another eligible firm/agency. In such case, the security deposit remitted will be forfeited.
14. The monthly rent with 18% GST shall be paid to Spices Board on or before 5th of every succeeding month.
15. During the operation of the facility, priority shall be given to the stakeholders in the Spices Park and the charges for using the facility shall be fixed in concurrence with the Board.
16. The interested firms may visit the weigh bridge at the Spices Park at Sivaganga, Tamil Nadu from Monday to Friday between 10 a.m. and 5 p.m. before the bid end date. They may contact the Officer in charge, Spices Park, Sivaganga in the following address before the visit.

17. The Board reserves the right to reject / cancel any or all bids without assigning any reasons thereof.
18. The Board will terminate the lease if the weigh bridge is not utilized continuously for more than 3 months or nonpayment of the monthly rent in time.

19. After completion of the tenure, the weigh bridge should be handed over to the Board in working condition along with valid license/documents.
20. EMD is not applicable to submit the Bid. However, the bidders shall submit the Bid Security Declaration in the prescribed format as given in Annexure-II.
21. The technical bid shall be submitted in the format given as Annexure-I along with Bid Security Declaration in the format given as Annexure-II in a separate envelope superscribing Technical Bid. (Envelope-1)
22. The financial bid shall be submitted in the format given as Annexure-III in a separate envelope superscribing Financial Bid. (Envelope 2).
23. The technical and financial bids (Envelope 1 and 2) shall be sent in a sealed cover superscribed as "Bid for Commercial Operation of the weigh bridge system established at Spices Park, Sivaganga" to the following address on or before 3.30 pm on 3.7.2023
