Now, the Board invites competitive Bids for renting the built up area for office space at Spices Park, Raebareli. The details of areas to be lease out are as follows:

Building space of 36 X 24 Square feet situated at ground floor
Building space of 40 X 40 Square feet situated at First floor

Terms and conditions for renting the Built-up area:

1. The facilities will be rented out in “As is where is” Condition
2. The facilities will be rented out for one year from the date of handing over of the building space.
3. Spices Board will provide water and electricity to the facilities on payment on prorated basis.
4. The facilities will be rented out to the bidder who has quoted highest rent per month as well as meeting other terms and conditions of the Board.
5. The highest bidder shall execute an Agreement with the Board within 15 days of the receipt of the offer letter from the Board.
6. The highest bidder, after receipt of offer letter, shall pay an interest free Security Deposit equivalent to three months’ rent and an interest free caution deposit of

Rs.25,000/- towards guarantee against any eventual unpaid payments of electricity, rent etc. through online bank transfer to Board's Receipt Account.

7. The security deposit and caution deposit without interest would be returned at the time of handing over the facilities to the Board. The security deposit will have to be remitted along with the agreement.
8. The highest bidder shall take possession of the facility within 15 days from the date of signing of agreement and after the remittance of Security Deposit.
9. If the possession is not taken within 15 days from the date of agreement, it will be treated it as breach of the tender conditions and the Board has the right to lease the facilities to other eligible firm/agency.
10. The monthly rent with 18% GST shall be paid to Spices Board on or before 5th of every succeeding month.
11. The facilities shall not be sub-let to any other firms.
12. The Board reserves the right to reject / cancel any or all bids without assigning any reasons thereof.
13. The Board will terminate the lease if the facilities are not utilized continuously for more than 3 months or non payment of the monthly rent in time.

Other terms

1. The bid application shall be submitted in the format given as Annexure-1
2. EMD is not applicable to submit the Bid. However, the bidders shall submit the Bid Security Declaration in the prescribed format as given in Annexure-2.
3. The bid shall be sent in a sealed cover superscribed as "Bid for renting out the built up area for establishing office space in Spice Park at Raebareli" addressed to the "The Assistant Director, Spices Park, Datauli Village, Harchandapur P.O, Raebarely, Uttar Pradesh-229303" so as to reach on or before 5.00 pm on 26.03.2024.
