Sub: Export Development and Promotion Scheme - Reimbursement of CRES Fee for SC/ST Exporters - Provision for Amendment of Category in CRES- reg

This has reference to Spices Board's scheme under the Export Development & Promotion component, for Reimbursement of fees for Certificate of Registration as Exporter of Spices (CRES). Under the scheme, reimbursement of 75% of the registration charges of CRES (excluding GST) subject to a maximum of Rs.11,250/- will be provided to the registered exporters in NE region (including Sikkim & Darjeeling region) & other Himalayan states / J&K and Ladakh, State Notified ITDP areas and Islands (Union Territories of Andaman & Nicobar and Lakshadweep), FPO exporters and SC/ST exporters across the country.

The following exporters shall be deemed to fall under SC/ST category

In case of proprietary concern, proprietor shall be from SC/ST category a)

In case of partnership firm, the SC/ ST partners shall be holding at least 51 b) % shares in the unit.

In case of private limited companies/Limited Liability Partnership (LLP)/Farmer c) Producer Companies (FPCs), at least 51% shares shall be held by SC/ST directors/promoters. The partner/director/promoter should hold at least 51% share in the unit for the preceding one year of application for financial assistance and the holdings of SC/ST partner/promoter/ director shall remain at a minimum of 51% for a subsequent period of at least two years of reimbursement of the financial assistance. In this regard, an undertaking has to be submitted by the applicant, before release of payment.

In the case of SC/ST exporters, the primary requirement for availing assistance under the Scheme is that the category shall be reflected as SC/ST, in the CRES system of Spices Board. If the category has not been specified while submitting the online application for obtaining CRES, a provision for amendment is now made available, using the link given below:

https://indianspices.org.in/CRES_new/e-r-o/exporters-registration/amendment/category.php After amendment the application for the scheme may be submitted through concerned Regional offices of Spices Board.

All the eligible exporters who fall under the SC/ST category as well as the registered exporters in NE region & other Himalayan states/ J&K and Ladakh, State Notified ITDP areas and Islands and FPO exporters are urged to avail assistance during FY 2021-22, under the scheme for Reimbursement of fees for Certificate of Registration as Exporter of Spices (CRES). In the case of SC/ST exporters, the firms may ensure that the category is reflected correctly in the CRES system of Spices Board, before submission of application.
