GAP IN SPICES: TRAINING COURSE FOR UNEMPLOYED YOUTHS

Spices Board has been offering training to unemployed youths belonging to agricultural families in the country to act as agricultural resource persons in various aspects involved in quality spices production. The Board is currently inviting applications from candidates from Kerala, Karnataka and Tamilnadu for 9th batch.

Under the programme, Good Agricultural Practices like good quality planting materials production, crop husbandry practices, integrated pest management (IPM)& integrated disease management (IDM), post harvest handling, storage and processing, organic certification requirements and organic production practices of selected major spices and herbs will be covered. The scheme is designed to act as an alternative extension mechanism fully conversant with good agricultural practices rooted in rural communities with self-reliance. The programme will help in bridging the gap in current yield levels and the potential yield of crops.

The objective of this programme is to train unemployed youths from agricultural families enabling them to act as resource personnel to improve the quality of spice production. The incumbents would provide an interface between the Board and Spices growers by rendering advisory services.

Curriculum:

Practical training on production of quality planting material, organic inputs such as vermi-compost, conventional composting, biodyanamic preparations, traditional knowledge based inputs such as *panchakavya*, biofertilizers, bioagents (*Trichoderma*, *Pseudomonas*, *Mycorrhizae* etc.), identification and management of major pests and diseases of spices, soil testing and advisory services, mechanization, post harvest handling and processing including on farm value addition will be imparted during this programme. Medium of instruction will be English.

Location:

The training will be provided at the Indian Cardamom Research Institute, Spices Board, Myladumpara, Idukki District, Kerala, 685 553.

Duration:

The duration of this programme is three months (April –June 2012) and 30 candidates will be trained. It is a compulsory residential programme.

Eligibility:

Unemployed youths from agricultural families including agricultural labourers with 10 +2(Science) or VHSC (Agriculture) qualification are eligible. Candidates who are members of Kudumbadree or similar farmers' group will be given preference. Candidates whose age is between 18-30 years as on 29/2/ 2012 only need to apply (33 years for SC/ST).

Stipend for trainees:

A stipend of Rs.2000/ per month during the period of training will be given to the trainees to meet expenses on travel, food and accommodation.

Post training activity:

After successful completion of this training programme, it is expected that the trainees will continue to engage themselves in agricultural based activity including production of quality spices in their own villages and provide side by side extension services to the spice growers, interested in sourcing their expertise on payment basis.
