Greetings from the Spices Board of India,

As you are aware, Spices Board (Ministry of Commerce & Industry, Govt. of India), the flagship organization for the development and worldwide promotion of Indian spices has been spearheading activities for promotion and facilitation of spice trade by strengthening linkages at various levels of the Spice Industry.

I would like to inform that India's spice exports, with a volume of 15,31,154 MT valued at Rs 30,576 crores during 2021-22, scaled the landmark level of US\$ 4102 million in value realization, besides recording a growth rate of 27% in volume, 39% in rupee terms and 32% in dollar terms, compared to 2019-20, despite the global pandemic situation.

Karnataka, the largest state in South India, holds a significant position in spice production in the country by being a major producer of Black pepper and Ginger. The state also produces other spices such as Cardamom(small), Chillies, Turmeric, Garlic, Coriander, Nutmeg, Clove, Tamarind, etc. During 2021-22, Karnataka produced 7,09,546 MT of spices from an area of 3,75,082 Ha.

Spices Board with a view to further promote the export of spices and spice products has been organizing Buyer Seller Meet (BSM), so as to provide a common platform for the Buyers and Sellers of the spice industry, to interact directly and establish effective business linkages. Accordingly, the Board is organizing a Buyer Seller Meet for Spices on 24th January 2023 at Hotel Crystal Court, Hilldale Resorts, Madikeri.

In this regard, we cordially invite you to attend the event. Accommodation shall be arranged by the Board for registered participants.
