**Conditions:**

3. It shall be the responsibility of the agency to dispose all debris and waste materials obtained during the course of work for which no extra charges shall be claimed.
4. Payment shall be made for the quantity as per actual measurements at site.  
Security deposit @ 5% of the executed value will be retained, which shall be released after completion of defect liability period of 6 months
5. Any defects noticed during the defect liability period of 6 months shall be rectified by the Contractor without any additional charges
6. Works shall be executed by following necessary safety guidelines and it shall be the responsibility of the Contractor to ensure all the safety measures for the workers engaged.
