This has reference to the Tender ID: SPICEB/20-21/ET/4 - Request for Proposal for Selection and Appointment of Service Providers for online sale of spices through the E-Spice Bazaar portal to facilitate sourcing for exports (Limited Tender) released by the Board in MSTC Portal and also in the Board's website.

In this regard, the tender document has been modified as given below.

- 1) The last date for submission of the technical bid has been extended to 29th November 2021. Accordingly, the bid schedule given vide page no 3 of the tender document is replaced with the bid schedule placed as Annexure I. It may be noted that **NO** further extension for submission of technical bid is being considered.
- 2) Clause No 12 (Other Terms and Conditions), sub- clause no 14 is modified as below.

Security Deposit – The successful firm (s) shall, along with execution of the agreement, furnish an unconditional Bank Guarantee to Spices Board, in the form acceptable to the Board, as security deposit. For the first year, the amount of Bank Guarantee shall be Rs. 10 lakhs. From the second year onwards, the amount of Bank Guarantee shall be 1% of the actual annual sale value through the portal during the previous twelve months, subject to a minimum amount of Rs. 10 lakhs. The Bank Guarantee amount will be reviewed periodically and the Board can enhance the Bank Guarantee amount, at any time during the tenure of the agreement with the successful firm (s).
