4. Tenders received incomplete or with rates below reserve price or with rates not as per prescribed format will be rejected
5. Those tenders found not signed by the bidders and defective for other reasons are liable to be rejected.
6. The offers quoted in the tender shall be valid for 30 days from the date of opening the tender.
7. Spices Board reserve the right to reject any or all the offers without assigning any reason whatsoever.
